The criteria for submissions

 The British Glass Biennale is open to artists, designers and craftspeople, working in all areas of contemporary glass practice or using glass as a key design element.

Applicants must:

- have been living and working in the United Kingdom of Great Britain and Northern Ireland for the last two consecutive years; or
- Be living, working or studying abroad but possess a British passport and have previously lived in the UK for a minimum of 15 years
- Each artist can submit up to three pieces for consideration.
- Each piece must be predominantly made of glass but can incorporate other materials.
- All pieces selected must have been made since 1st June 2015.
- All works selected for display must be for sale.

The online application will be available in the New Year

Deadline for submissions: 20 February 2017

Information on the prizes will be available soon.

Exhibition Dates: Awards Ceremony 24 August; open 25 August – 9 September

(closed on Sundays)

James Measell and the Northwood connection

Having devoted much of his adult life to University teaching, in 1997 James Measell took the post of historian/archivist at the Fenton Art Glass Company in Williamstown, West Virginia, USA. A keen glass collector, he is particularly interested in our own Harry Northwood (1860-1919), who attended the Stourbridge School of Art in the 1870s before emigrating to the United States, where he headed several glass companies.

James' interests occasionally bring him 'across the pond' to Stourbridge and it was during one such visit in 2010 when, due to an unbelievable string of coincidences that I need not detain the reader with here, we first met. James became a good friend to BGF and his connections to the area were augmented by his distance-undertaking of (another!) PhD under the supervision of BGF supporter, Dr Malcolm Dick of the University of Birmingham.

We are delighted to learn that James has successfully completed his thesis and has made a most generous offer that will be of interest to all enthusiasts but particularly those researching their local glass history and ancestors. He tells us:

Hi Graham. I had the viva over my PhD thesis at the University of Birmingham in July and it is now deposited in their library. It is entitled: A provincial school of art and local industry; the Stourbridge School of Art and its relations with the glass industry of the Stourbridge District 1850 - 1905.

I'd be glad to send a pdf file of the thesis via email to any reader of GlassCuts. Be warned, it's a big file (16-17 MB). Using the latest Adobe Reader almost all of it can be 'searched' for key words, that enables searches for the surname of an ancestor who attended the school and/or was known to work in the Stourbridge Glass industry. One appendix lists the students who won local or national awards as well and another is a transcription of the original handwritten student class rosters from 1864-1874 (the original ledger is in the Dudley Archives and Local History Centre and was purchased for Broadfield House at the Jack Haden auction sale).
