In memoriam

We are greatly sorry to hear of the death of our friend and benefactor Clive Richards CBE KSG DL and it is with great sadness we reproduce in full this news from the website of the Clive & Sylvia Richards Charity https://www.csrcharity.com/



Clive Richards, aged 83, made Herefordshire his home for the last 38 years. He was born and educated in Birmingham/Black Country and qualified as a Chartered Accountant, Cost and Management Accountant and Chartered Secretary in 1959. Having moved to the City of London in 1960 he spent 50 years becoming a serial entrepreneur building up 10 PLCs in various industries subsequently merging/selling them.

Outside his business career, his major interests were the Estate in Herefordshire where there are 2 farming enterprises, Lower Hope Farms & Lower Hope Fruit where they grow the most delicious prizewinning cherries. He won Fruit Grower of the Year in both 2011 and 2015.

His other interest was the Clive and Sylvia Richards Charity which was established in 1986/7. It currently gives away  $\pounds 1 - \pounds 2M$  a year to a wide variety of charities including education, hospitals, hospices, heritage and overseas. The Charity has grown over the years and now has 6 independent Trustees. (We are proud to acknowledge his largesse towards BGF by way of a substantial donation a few months back – Ed)

He was awarded the Knighthood of the Equestrian Order of St. Gregory the Great, by Pope Francis in 2018 and in January 2020 he was awarded the Commander of the British Empire for services to charity and to the community in Herefordshire.

Clive was passionate about so many things and endeavoured to help as many as he could either by advice, support via his Charity, fundraising events and opening his beautiful gardens at Lower Hope. He would often be seen wandering around his garden on the National Garden Scheme open days with his beloved Labrador dogs not far behind.

He kept strong connections with his old Grammar School, Bishop Vesey in Sutton Coldfield, as his education and guidance there set him off on his career path to, in his own words, 'make a few bob' which he later generously shared with others.

He has been a mentor to many now very successful businessmen, singers, musicians, sportsmen, doctors and accountants.

Over the years he was actively involved with the Herefordshire Young Farmers, most of the schools in Herefordshire and beyond where many have annexes, buildings, football/rugby pitches, new classrooms etc named after him, Malvern Theatres, Conquest Theatre, Bromyard Leisure Centre, Bromyard Sports Foundation and Bromyard Rugby Clubs to name just a few.

Clive lived his life to the absolute fullest. A keen sportsman in cricket and rugby playing at county level, went skiing twice a year, enjoyed sailing, fishing and shooting.

Clive passed away peacefully at home on Friday 16 April. He is survived by his wife Sylvia, 3 children and 4 grandchildren.

On behalf of all at the British Glass Foundation we offer our sincerest condolences to Clive's family and his many friends. Clive Richards CBE KSG DL (1937 - 2021) R.I.P.

#### Answers from previous

#### Dave Tyler's items and his forebears in the Breese family, GC178

James Measell, glass historian and BGF Trustee tells us from his home in the States: 'I'm sure I have some info about the Breese family in the 19th C. Stourbridge glass industry. If you can forward my email address to Dave Tyler, I'd be glad to correspond with him'. So we did. And the two have since been in touch to exchange information and even possibly arrange a link up between James and a descendant of Dave's family Breese. Now isn't that worth it all?

#### The Woodall cameo, also GC178

On 23rd April almost immediately after auction of this piece, which was estimated at \$800 - \$1200, and in an astonishing example of the enduring power of Stourbridge cameo, we received this breathtaking email from our Trustee James Measell: '*The cracked Woodall cameo sold for \$22,000.00 (that's the hammer price; the buyer's premium adds at least 23% more and could be as high as 28% depending upon the method of payment'*. The auction-house site now indicates the final figure, including buyer's premium, to be \$27,060. No, that's not a misprint. \$27,060. Dilwyn Hier, of Antique Stourbridge Glass, has kindly provided us with a more detailed background and, in view of the significance of this piece - indeed of Woodall, too - we are pleased to record his contribution here in full. For which, we might add, we are most grateful.

'Hi Graham. I attach some additional information and images for you to use as you see fit. Contrary to your expression of amazement the priced realised was to be expected, ignoring American presale estimates that are always ludicrous one way or the other. The last figurative plaque to be sold at Fieldings had a hammer price of £84,000 plus 30% commission, and the work was nowhere near as good. The damage, which did not detract from its appearance, would be expected to reduce the value to 25% of the intact price'.

### Armistice (A Truce)

Woodall's inspiration

This very fine cameo was carved on 13½", white on raisin brown plaque. It depicts two armed cherubs taking a break and is entitled "Armistice (A Truce)". Signed G. Woodall 1886.

The subject matter is based on an original oil on canvas painting by Emile Munier (1840 – 1895) signed and dated 1883. The painting was first exhibited, *in* 1883 at the *Paris Salon* (*Salon* de *Paris*), the official art exhibition of the Académie des Beaux-Arts in *Paris*.

Emile was a prolific artist using his children Henri and Marie Louise as his principal inspiration during the 1880s. Other examples of his work were used for Pears' Soap advertising.

Although the painting was reproduced in lithographs, the detail in Woodall's cameo reflects the detail of the original painting which suggests that he had seen the painting first hand and perhaps even photographed it.

There is no previous record of this Woodall work and the dated signature identifies it as one of his early figurative cameo works. The first signed and dated George Woodall figurative cameo work was, "*Aphrodite\_and Cupid*"; a white on plum 13" plaque signed in the cameo "*G. Woodall/1884*"; now in the collection of Corning Museum of Glass.

The plaque had sustained a fracture in the early days of its life and was stabilised in a contemporary frame. How the damage was caused is unknown but the nature of the crack implies it more likely to be a stress crack than one sustained from trauma. Considering that such a cameo work took many weeks if not months to complete the date of 1886 shows that Woodall was very much aware of the art world at the time and was able to copy the subject that had been created less than three years earlier. This is the earliest piece of Woodall's worked to be linked directly to the work of a contemporary artist.

#### Nature's Mirror

The only other work to be positively identified as a copy of an artist's painting is a two handled vase; pattern W2728, entitled "Nature's Mirror" produced by Thomas and George Woodall in 1891. This Woodall work again faithfully reproduces the painting by Friedrich Paul Thumann (1834 - 1908) originally titled "Psyche at Nature's Mirror". The painting is signed Roma, which would mean it was painted between 1887 & 1891 when Thumann was living in Italy.

The word "psyche" in Greek means both butterfly and soul. In Greek Mythology, Psyche was a maiden of rare beauty who was envied by Venus and loved by Eros (Cupid). She personified the soul and was made immortal by Zeus. The painting was exhibited at The World's Columbian Exposition of 1893 (Chicago World's Fair) where it attracted great attention, in particular, the management of the "White Rock Mineral Water" manufacturers who purchased the reproduction rights from Thumann to use the image as part of the logo for their mineral water.





#### New teasers

David Tubbs says: 'I found a glass bottle embedded in a stream bank on the English/Welsh border in Shropshire. I've never seen anything like it and would very much value your opinion on its age, use, and the unusual internal structure'. We confess it has us stumped, so over to you please.





And we finish off this session with a query from Cheryl Hayes: 'I am wondering if you can help me, I inherited some paperwork that has Broadfield House Glass Museum on it and I believe it has closed. (30.9.2015 - Ed). I am hoping to find information on John Osman born Abt. 1874 and Thomas Osman born Abt. 1850. I believe they were both Glass Makers and I believe they are related to my husband's great-grandmother. We inherited a glass jug and six glasses that were sent from England to Australia in 1930 as a wedding present. We were told it was made by a family member who was part owner in a glass company (or may have just worked with the company). It has to be either an Osman or Hayes. I believe it to be Osman as I have not found anything about Hayes's being glass makers in England but only in France. Any information you have and could help me with would be greatly appreciated.'
